## **Local Governing Body Constitution**

### **~ King's Academy Brune Park ~**

#### ***Preamble:***

The LGB should annually review their constitution to ensure the board has the correct mix of skills and experience, as well as the number of governors. This reflects the DfE's principles on the constitution of boards to ensure they are manageable and effective.

i) KGA's Articles of Association only stipulation is that there should be two parent governors

ii) KGA's Scheme of Delegation states:

- Up to 7 Trustee Appointed Governors (this can be exceeded if the Trustees so wish)
- Up to 2 staff governors.
- Ex Officio members (Principals/Heads or Executive Head)
- Minimum of 2 Parent Governors

*iii) There is the option for the LGB to co-opt governors, however, the Term of Office for a co-opted governor is for one year and only by direction of the Trustees. These roles are used if there is a specific function or project that they have the expertise to deliver.*

iv) Staff should not exceed comprising one-third of the LGB composition. This includes Staff Governors, Ex Officio and Trustee Appointed governors who are staff members in the Academy or the Trust as a whole. Therefore, to take into account non-staff governors who may resign at any moment and tip the balance, it is best practice to have as few or no staff members in roles outside of the Staff Governor/Ex Officio roles.

v) Terms of Office should be for four years, apart from Ex Officio - they do not have an end date.

#### ***Staff and Parent Governors:***

vi) These governors are elected by their peer group. It is essential that they understand that they are not representing or presenting the views of the peer groups, but their role, like all governors, is to act in the best interests of the academy as a whole.

**SLT as Staff Governors:**

vii) All SLT should have a blanket invite to all LGB meetings as part of their CPD and their professional role to provide information to the LGB. It is important that the staff governor brings a non-leadership perspective to the role.

**Process of the Constitution:**

viii) At the first meeting of the academic year the Constitution should be added to the Agenda where the LGB should agree if there are any changes needed, this could be based on a Self review of Governance, The Academy Improvement Plan or other factors.

ix) The LGB should discuss if there are any governance projects that require specialist skills and, therefore, Co-Opted Governors. If so, a proposal should be submitted to the Lead Governance Professional for approval at the next Full Trust Board.
